- Package #1: Before & After School, all Early Outs and 1/2 days \$65/week draft
- Package #2: Before School, all Early Outs and 1/2 days \$45/week draft
- Package #3: After School, all Early Outs and 1/2 days \$50/week draft

*Scheduled School Day Outs will be \$25 per School Day Out with package.

*All packages include snow days.

Daily rates for non-package deals:		
School Day Outs	(6:30 am – 6 pm)	\$30 per School Day Out
Early Outs	(2 pm – 6 pm)	\$20 per Early Out
1/2 Days	(11:45 am – 6 pm)	\$25 per Half Day

***You must have childcare registration fee and paperwork on file to participate in above packages.**

- **There is a non-refundable \$30 Childcare Registration Fee per family each calendar year.**
- **First payment will be drafted on August 16th; ALL PAPERWORK MUST BE TURNED IN BY AUGUST 5TH FOR YOUR CHILD TO ATTEND BEFORE/AFTER SCHOOL CHILDCARE.**

**Childcare will be CLOSED on the following days:
August 13 & 14, September 3, November 22 & 23, December 24 – January 1**

Step 3: Complete checklist

- I have already paid my registration fee this calendar year (after January 1, 2018) of \$30.
- I have filled out all paperwork including but not limited Immunization forms, DDHS Children’s Record and Statement of Authorization.
- My child attended Summer Camp 2018 and all of my records on file have been updated in 2018.

 - Parents keep brochure, return receipt to the Y.
- I have received and read the Parent Handbook; I have signed and included the Acknowledgement of Receipt found on the last page of the handbook.
- \$30 Family Registration Fee has been paid.
- Behavior/Medication/Extended Hours Policies signed
